## DISCLOSURE OF OTHER RELEVANT INFORMATION

In order to fill the vacancy that has arisen on the Company Board of Directors, as a result of the resignation tendered by the Proprietary Director Mr. Francisco Ferrer Moreno due to his recent appointment as General Secretary of Paradores, the Company Board of Directors has agreed, at the proposal of the majority shareholder ENAIRE and following a report from the Appointments, Remuneration and Corporate Governance Committee, to appoint Mr. Raúl Míguez Bailo as Proprietary Director of the Company, effective today and for the four (4) year term established in the Articles of Association, subject to his approval or ratification at the first meeting of the Company's General Shareholders' Meeting.

Likewise, given that Mr. Francisco Ferrer Moreno was a member of the Audit Committee and of the Executive Committee, in view of the vacancy that has arisen in both committees, the Company Board of Directors, effective today, has agreed to appoint Mr. Raúl Míguez Bailo as a new member of the Company Audit Committee and Executive Committee.

The Councillor has accepted the posts.
